## BOYNE HILL CRICKET CLUB 200 CLUB RULES

1. The name of the draw is the Boyne Hill Cricket Club 200 Club, otherwise known as the 200 Club, regardless of the number of members.
2. The purpose of the 200 Club is to raise funds for the sole benefit of the Boyne Hill Cricket Club.
3. The draw will be administered by the 200 Club Secretary appointed by the Boyne Hill Cricket Club managing committee. Refer to the 200 Club page on the Boyne Hill Cricket Club website for the 200 Club Secretary contact details -

4. The 200 Club is only open to participants 18 years and over.
5. By joining the 200 Club, the Participant automatically receives entry in to the monthly 200 Club draw as well as Social Membership to Boyne Hill Cricket Club.
6. There are a maximum of 200 numbers within the 200 Club. Ranging from number 1 through to number 200.
7. Participants may hold multiple numbers giving increased chances of winning a monthly prize draw.
8. Participants will be allocated a specific number at the time of enrolment. This number will remain assigned to the participant until the time they decide to leave the 200 Club.
9. The monthly cost of each number is £2.00.
10. All Participants are to pay in advance by Standing Order on the first day of each month in to the Boyne Hill 200 Club bank account.
11. There shall be twelve 200 Club prize draws each year, representing one per calendar month.
12. The value of each monthly prize draw is as follows.

April £200.00	May £20.00	June £200.00
July £20.00	August £200.00	September £20.00
October £200.00	November £20.00	December £200.00
13. Each prize draw must be held in the presence of at least 3 members of the Boyne Hill Cricket Club managing committee on such occasions and times the 200 Club Secretary deems appropriate.
14. The winning number for each monthly draw will be selected at random.

16. Payment of the prize money will be by direct deposit into an account nominated by the winner. Alternative in the form of a cheque written in the name of the winning Participant.
  - a. Cheques will be posted to the address held on file for the winning Participant.
  - b. Participants are responsible for ensuring correct address details are provided to the 200 Club Secretary. Any changes of address must be communicated in writing to the 200 Club Secretary.

17. Unclaimed and/or uncashed cheques within 6 months will be deemed a donation to the Club.
18. Only numbers for fully paid-up Participants will be included in the monthly draw.
19. If a Participant fails to pay for their number(s) in advance of the monthly draw, the Participants number will be withdrawn from that months and all future months draws until payment is made.
20. It is the responsibility of each Participant to ensure their monthly standing order is successfully processed and sent to the 200 Club bank account.
21. Participants may leave the 200 Club at any time by giving one month's written notice to the 200 Club Secretary. Participants are responsible for cancelling their monthly Standing Order with their bank.
22. Once a Participant has left the 200 Club, their number(s) will be reallocated to new members.
23. If the number of paid numbers falls below 50, the 200 Club Secretary reserves the right to immediately terminate the 200 Club and all future prize draws. A single prize draw will then be held for the cash balance in hand in such proportions as the 200 Club Secretary deems appropriate.
24. The 200 Club Secretary will make decisions in the event of any disputes. An appeal may be made in writing to the Boyne Hill Cricket Club managing committee, who will convene a sub-committee consisting of the Chairman, Secretary and one other member of the Boyne Hill Cricket Club managing committee. The decision of the sub-committee shall be final.
25. The 200 Club will pay out through prize draws a maximum of 48% of the total annual income. 2% of annual income will cover administration costs. The remaining 50% will go to Boyne Hill Cricket Club. Should 48% of the total annual income exceed the total prize money in the schedule above, then the surplus balance will be paid out via a one-off special prize draw as determined by Boyne Hill Cricket Club managing committee.
26. The rules for the 200 Club may be amended at any time subject to agreement by the Boyne Hill Cricket Club managing committee.
